Solicitor Scacchitti – Funds invested in a CD by a Township has no limit. The amount should not exceed the FDIC backed amount. We can deal with more than one bank.


Paula Noto – Concerned about the solar farm. A public meeting that is advertised needs to be scheduled by early February.
