Supervisors' Monthly Meeting

Vice Chairman Wells called the Meeting to Order at 6:00 p.m. with the Pledge of Allegiance

Roll Call: Chairman Bird absent, Vice Chairman Wells and Supervisor Scott - present – Quorum declared

In attendance: Jerry Blackwell, Lenay Blackwell, Bob Lukasiewicz, Artie and Angelika Mercado, Sergeant Snyder and Chief LaCoe.

Minutes from the November 10, 2025, meeting were read by Secretary – Supervisor Wells made a motion to accept the minutes as read – 2<sup>nd</sup> by Vice Chairman Wells – all in favor – motion carried

**POLICE REPORT:** Sergeant Snyder reported Taylor Borough officers responded to 137 incidents which included building checks, investigations, patrols and traffic stops. They have increased their frequency of checking up on issues.

**FIRE REPORT:** Chief LaCoe said he would get the Ransom fire and EMS calls to us for this report. He reported 3 Fire responses, and 5 EMS calls for November.

**TOWNSHIP OFFICIALS:** Vice Chairman Wells reported an upcoming change in millage for 2026 due to the new assessment. The Supervisors are working on finalizing the budget and securing a new Sewage Enforcement Officer.

**SOLICITOR:** Solicitor Conaboy confirmed the Cascades settlement was finalized. We also received a request for a Zoning change to allow for a Data Center where Scranton Materials is located on 819 Newton Road. The hearing will be before the Board of Supervisors in early to mid-January. He expects to confirm the dates at the next meeting.
