Supervisors' Monthly Meeting

Chairman Bird called the Meeting to Order at 6:00 p.m. with the Pledge of Allegiance

Roll Call: Chairman Bird- present, Vice Chairman Wells -present, and Supervisor Scott - present – Quorum declared

POLICE REPORT: Sergeant Snyder reported that Taylor police had responded to 120 incidents including building checks, patrols, investigations and traffic stops.

FIRE REPORT: Chief Summerhill gave the fire report citing 6 responses in Ransom: 5 EMS and 1 Fire/EMS. He asked if their fuel was frozen, could Ransom help with that? Solicitor Conaboy said that was possible with the condition they figure out reimbursement.

TOWNSHIP OFFICIALS: The Supervisors appointed New Planning Commissioners: Tyler Milo, Joseph Harris, Marc Bozzacco, and Ryan Stan (Alternate). Chairman Bird also shared that we are Celebrating our nation's 250th Birthday with Lackawanna County offering grant funding with which we will buy a commemorative bench.

SOLICITOR: Solicitor Conaboy gave an update on the solar farm: arguments are to be made March 31st before Judge Nealon. A written decision will be out soon on the data center. The shooting range is in front of a judge who may decide the issue or send it back to the Ransom Township Zoning Hearing Board.
