Chairman Bird called the Meeting to Order at 6:00 p.m. with the Pledge of Allegiance

Minutes of the April 7, 2025 meeting were read by Secretary – Supervisor Wells made a motion to accept the minutes as read – 2<sup>nd</sup> by Supervisor Scott– all in favor –motion carried

**POLICE REPORT:** Officer Brian reported 65 Taylor police responses in Ransom Township including 5 wellness checks, 19 building checks, 1 dog complaint, 3 road hazards, 8 traffic stops, 1 burglary, 1 criminal mischief, 4 suspicious vehicles, 1 motor assist, 1 vehicle fire and 1 unauthorized use.

**FIRE REPORT:** Chief LaCoe reported 4 responses in Ransom Township – 3 Fire and 1 EMS. The individual suspected of and charged with setting the fires is now in police custody thanks to a cooperative effort of law enforcement and our local first response agencies.

**TOWNSHIP OFFICIALS:** Chairman Bird met some potential contacts for the creek issues at conference in Hershey and is following up with them. Representative Bresnahan office said that flood funding is not out there at this time on the federal level.
